Also, you'll notice our Form 990 for 2010 lists us as "Northwest Arkansas Community Foundation" rather than "Endeavor Foundation." Rest assured, we are one and the same. This was our previous name, used from our founding in 1999 until the name change to Endeavor Foundation in October 2011. Next year's Form 990, as well as any other official documents created after October 2011, will reflect that name change, identifying us as Endeavor Foundation.
